STATEMENT UNDER GENERAL INSTRUCTION E: REGISTRATION OF ADDITIONAL SECURITIES

This Registration Statement registers additional shares of the Common Stock of Intevac, Inc. (the "*Registrant*") to be issued pursuant to the Registrant's 2004 Equity Incentive Plan.
