### Item 1.01. Entry into a Material Definitive Agreement

At Intevac, Inc.'s ("Intevac") annual meeting of shareholders held on May 15, 2007, Intevac's shareholders, upon the recommendation of Intevac's board of directors, approved an amendment to the Intevac 2004 Equity Incentive Plan (as amended, the "Plan") to increase the number of shares of common stock reserved for issuance pursuant to stock options by 900,000 shares.

A brief summary of the Plan is included as part of Proposal No. 3 in Intevac's definitive proxy statement filed with the Securities and Exchange Commission on April 16, 2007. The summary of the Plan contained in the proxy statement is qualified by and subject to the full text of the Plan, which summary is incorporated herein by reference.
